Clark County, Nevada SIXTH AMENDMENT TO THE FY 2020-2021 ACTION PLANCDBG-CV

Amendment of the Community Development Block Grant (CDBG-CV) for the Coronavirus Aid, Relief, and Economic Security (CARES) Act of 2020

The Sixth Amendment of the Clark County Substantial Amendment to the 2020 Action Plan revises the CDBG-CV spending plan to fund Public Facilities activities. Clark County is proposing to reprogram \$3,700,000 of CDBG-CV funds from Homeless Services to Public Facilities activities in response to Covid-19 related housing and health needs including homeless households which are highly vulnerable to poor outcomes.

CDBG-CV Provisions

This funding is intended to prevent, prepare for, and respond to coronavirus, including activities within entitlement and non-entitlement communities, based on public health needs, risk of transmission of coronavirus.

To expedite grantees' use of CDBG-CV funds, HUD is waiving the requirements at 42 U.S.C. 12705(a)(2) to the extent it requires updates to the housing and homeless needs assessment, housing market analysis, and strategic plan and 24 CFR 91.220 and 91.320 to the extent the action plan is limited to a specific program year to permit grantees to prepare substantial amendments to their most recent annual action plan. Grantees must identify the proposed use of all funds and how the funds will be used to prevent, prepare for, and respond to coronavirus.

The Department of Housing and Urban Development has also waived 24 CFR 91.505, reducing the number of public notice days to a minimum of 5, to facilitate the use of the CDBG-CV funds to the extent necessary to require submission of the substantial amendment to HUD for review in accordance with 24 CFR 91.500.

The CARES Act removes the statutory 15% cap on the amount of a jurisdiction's CDBG allocation that can be used for "public services," which the provision of rental or utility payment assistance would normally be considered. The Act limits the exemption from the 15% cap to "activities to prevent, prepare for, and respond to the coronavirus". The Act also states that a jurisdiction's FY19 and FY20 CDBG allocations are also free from the 15% public-service cap.

CDBG-CV grants are subject to the requirement that 70% of funds are for activities that benefit Low and Moderate Income (LMI) persons. 80% of CDBG-CV funds must be expended by the end of the third year of the six-year period of performance. The receipt and expenditure of program income that is generated by the use of CDBG-CV funds will be treated as annual formula CDBG program income.

CDBG-CV grants are subject to all environmental review requirements outlined in 24 CFR Part 58 as well as Davis-Bacon prevailing wage requirements imposed by section 110(a) of the HCD Act.

CDBG-CV grantees are subject to the requirement that prevents the duplication of benefits that is caused when a person, household, business, or other entity receives financial assistance from multiple sources for the same purpose, and the total assistance is more than the total need.

CDBG-CV Application Procedure

HUD has allowed for an expedited citizen participation procedure in which virtual public hearings are utilized and a public comment period of no less than 5 days is permitted.

Per the Declared Emergency Citizen Participation Plan, applications will be reviewed by a group of county employees from several departments and all recommendations will be taken to the Board of County Commissioners for public comment and approval.

The County will consult with the two cities participating in its Urban County CDBG program, the City of Boulder City and the City of Mesquite to identify projects in these cities to be funded with CDBG-CV funds.

BACKGROUND:

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security (CARES) Act of 2020 was signed into law to assist communities in their efforts to prevent, prepare for, and respond to the novel coronavirus COVID-19. The CARES Act allocated a total of \$14,444,984 in CARES Act CDBG-CV to Clark County.

On July 7, 2020, the Board of County Commissioners approved the submittal of the FY 2020 Action Plan for Housing and Community Development to the U.S. Department of Housing and Urban Development (HUD), which HUD subsequently approved.

On December 1, 2020, the Board of County Commissioners approved the submittal of a Substantial Amendment to the 2020 Action Plan for Clark County to receive and administer the \$14,444,984 in CARES CDBG-CV funding from HUD, including CDBG Round 1 (CDBG-CV1) of \$4,731,978 and CDBG Round 3 (CDBG-CV3 Part A) of \$9,713,006. It also included the approval to create limited permanent grant-funded staff positions to CDBG-CV funding; one (1) grants coordinator (C29) and two (2) part-time management assistants.

The purpose of the Sixth Substantial Amendment to the FY 2020 Action Plan for Housing and Community Development is to reprogram \$4,000,000 of CDBG-CV funds from Homeless Services to Public Facilities activities.

The reprogrammed funds will support the construction of property for The YMCA of Southern Nevada's Torrey Pines Early Learning Village project. This initiative will transform a pop-up preschool model into a permanent early childhood education (ECE) facility located at the Torrey Pines Community Recreation Center. The acquisition will enhance the YMCA's capacity to deliver essential services and implement preventative measures aimed at protecting vulnerable populations from future pandemics similar to COVID-19.

The Sixth Amendment submitted to HUD for approval includes CDBG-CV funding as outlined.

The District Attorney's office has reviewed and approved this Substantial Amendment as to form.
